Apply only as directed. Apply during the growing season. Use Andersons Golf Products Turf Fertilizer 15-0-29 when a high potassium fertilizer with slow release nitrogen is needed. All of the nitrogen in this product is derived from MUtech.

### Application Rates:

LOW:	1.75 lbs./1,000 sq. ft.
MEDIUM:	3.50 lbs./1,000 sq. ft.

### For all applications:

- Apply to dry foliage.

### Cool Season Grasses:

- Apply at the MEDIUM RATE.
- Apply at the LOW RATE when temperatures exceed 85°F.

### Warm Season Grasses:

- Apply at the MEDIUM RATE.

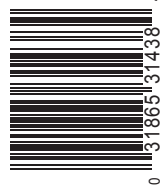
