Apply only as directed during the growing season. Apply any time putting greens need a low phosphate or high potassium feeding or when minor elements are desired to prevent deficiencies.

Apply at the MEDIUM RATE (1.0 lbs. N/1,000 sq. ft.).

Recommend applying at the LOW RATE (0.50 lbs. N/1,000 sq. ft.) during hot/humid conditions on established turfgrass.

NOTICE: Apply to dry or wet foliage and water immediately after application with a minimum of 0.20 inches to prevent staining or tracking from micronutrients.

Application Rates:

Low: 2.65 lbs./1,000 sq. ft.
Medium: 5.27 lbs./1,000 sq. ft.
