DIRECTIONS FOR USE

Apply only as directed during the growing season. Use Turf Fertilizer 19-3-19 on fairways, roughs and other turf areas as a starter fertilizer to promote vigorous seedling development and root establishment. Use also to correct or prevent phosphorus deficiencies.

Application Rates:
 MEDIUM: 5.3 lbs/1,000 sq. ft.
 HIGH: 6.6 lbs/1,000 sq. ft.

For all applications:

- Apply to dry foliage.
- Water in after application with a minimum of 0.2 inches to help move particles into the turf canopy.
- Do not collect clippings for at least one mowing following application to avoid particle pick-up.
- Do not use on greens or other low-cut turf.
- Do not use a drop-type spreader.

Established turf:

- Apply at the HIGH RATE.
- Exception: Apply at the MEDIUM RATE when temperatures above 85°F are anticipated.

Bare Ground Seeding, Sodding or Sprigging:

- Apply at the MEDIUM RATE to the soil surface.
- Lightly drag or rake the fertilizer into the upper 1/4 inch of soil.

Note: This product contains the micronutrient iron for extra greening and to help prevent iron deficiency. Iron may stain concrete and other surfaces. Misapplied product to these surfaces should be removed promptly by sweeping or blowing. DO NOT WASH OFF WITH WATER.

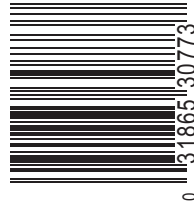
